ORDER FOR SUPERVISED VISITATION AND ORDER OF REFERRAL TO THE SUPERVISED VISITATION CENTER

On today’s date the Court heard evidence and argument of counsel and finds that the following Orders are in the best interest of the child(ren) the subject of this suit.

Any and all periods of visitation of the child(ren) the subject of this suit shall be supervised for the following person herein after referred to as “Supervised Person”:

The Court further finds that ordering the supervised visitation to take place at the Supervised Visitation Center (SVC) located at 1504 E McKinney, Denton, TX, 76209 (The Law Center) is in the best interest of the child(ren).

The Court further finds that ordering the “Supervised Person” to follow the requirements of the SVC is in the best interest of the child(ren).

Therefore, IT IS ORDERED:

1. Any and all possession of, accesses to and visitation awarded to the “Supervised Person” and the child(ren) the subject of this suit shall be SUPERVISED at the SVC at the address provided herein above.
2. All Supervised Visitation shall be scheduled by calling 940-354-5406 or by scheduling online at www.kidvisits.com.
3. Visitation shall take place as follows: (for instance – 2 times per week for 1 hour each visit for 6 weeks).

First visit shall take place on or before:

_____ Visitation supervisors may arrange different times with cooperation of both parties.

4. A one time facility fee for the use of the Supervised Visitation Center shall be paid by the following person in the amount of one hundred dollars (\$100.00), or other amount as determined by the court to wit: \$_____. Said fee shall be paid in any of the following forms: Cash, money order or certified check, made payable to DCLF. A credit or debit card may be used to pay by sending a request to info@kidvisits.com. The one time facility fee is payable by the following party:

5. A supervisor fee of \$65 per hour, or other amount as determined by the court, to wit: \$_____ shall be paid directly to the visitation center on or before the date and time of the scheduled visitation. Said fee shall be paid in any of the following forms: Cash, money order or certified check, made payable to DCLF. A credit or debit card may be used to pay by sending a request to info@kidvisits.com. The supervisor fee is payable by the following party:

7. The child(ren) shall be timely transported to and from the SVC for the supervised visit by:

8. Upon the condition that a scheduled visit must be cancelled by any party, said cancellation shall occur not less than 24 hours prior to the time scheduled for the supervised visit to begin. The cancelling party shall cancel directly by calling 940.354.5406 shall notify all parties simultaneously. It is Ordered that any party who violates this cancellation policy shall pay the Supervisor fee in the manner described herein within 24 hours of the time in which the visit was scheduled to begin.
9. Any party who arrives for supervised visitation more than fifteen (15) minute after their visitation is scheduled to start will be considered a no show. The Supervisor fee

will be payable by the party who no showed in the manner described herein within 24 hours of the time in which the visit was scheduled to begin.

10. All supervised visits at the visitation center are to be limited to the Supervisor, the Supervised Person and the children the subject of this suit. Other persons are not permitted to attend any portion of the supervised visit.

11. The parking lot of the SCV shall have full camera coverage 24/7. Recordings shall be maintained for 90 days or as the SVC manages through its regular course of business. A copy of videos may be obtained upon written request with at least fourteen (14) days' notice. The requesting party shall send an email to info@kidvisits.com and a formal request form will be provided.

12. The Supervised Party shall arrive fifteen (15) minutes before the visitation is scheduled to begin and shall remain in their vehicle until contacted by the supervisor. The party who is bringing the child shall wait in their car until The Supervisor comes to the parking lot to obtain the child(ren) for the visit. Concluding the scheduled visitation, the party who is retrieving the child from the vitation facility shall remain in their vehicle, and the Supervisor will accompany the child(ren) to the parking lot and into that parties vehicle. The Supervised Party shall remain in the visitation facility until the child(ren) has left the parking lot.
